## COMPLETE RELEASE FORM, WAIVER OF ALL CLAIMS, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

- 2. I understand that my use of the Gun Range is voluntary and I may decline to use the Gun Range. I further understand that it is my obligation and responsibility to continually look out for any conditions or circumstances that may be unsafe. If, at any time, I feel anything to be unsafe, I will immediately notify a Gun Range official, and, if necessary, immediately leave the area or stop participating in the event which I feel may be unsafe.
- 3. It is the intention of all parties that in consideration for permission to use the Gun Range, the undersigned voluntarily does release, waive, discharge, and hold harmless the Gun Range and its directors, investors, officers, owners, shareholders, licensees, heirs, successors, administrators, assigns, insurance company, employees, agents and, affiliates from any and all claims, demands and causes of action of any nature whatsoever which I, the undersigned, or my spouse, family assigns, successors, or others that may claim through or under me, may have against any or all of them, for, on account of, or by reason of, the undersigned's assumption of this risk.
- 4. The undersigned covenants that the undersigned or anyone on the undersigned's behalf, shall not now or at any time in the future, directly, or indirectly, commence or prosecute any action, lawsuit, or other proceedings against the Gun Range and its directors, investors, officers, owners, shareholders, licensees, heirs, successors, administrators, assigns, insurance company, employees, agents and, affiliates concerning, arising out of, or related to the actions, claims, and demands hereby waived, released, or discharged by the undersigned. If the undersigned is under 18 years of age, it is understood that the parents or legal guardians of the undersigned are legally responsible for, and bound by all conditions and terms of this Agreement.
